<p>Home study: The expected total fees and estimated expenses for home study preparation and approval, whether the home study is to be prepared directly by the agency or person itself, or prepared by a supervised provider, exempted provider, or approved person and approved as required under §96.47 & 96.40(b)(1)</p>
<p>Adoption expenses in the United States: The expected total fees and estimated expenses for all adoption services other than the home study that will be provided in the United States. This category includes, but is not limited to, personnel costs, administrative overhead, operational costs, training and education, communications and publications costs, and any other costs related to providing adoption services in the United States. 96.40(b)(2)</p> <ul style="list-style-type: none"> • Birth parent counseling services provide emotional support, education, and guidance to expectant or birth parents considering an adoption plan. Services may include discussing parenting and adoption options, preparing for placement decisions, coping support before and after placement, referrals to community resources, and ongoing counseling designed to support the emotional well-being and informed decision-making of birth parents throughout the adoption process. • Foster Care Licensing is required prior to finalization. MYP will assist adoptive families requiring foster care licensing based on Colorado regulations, the child's legal status, or program requirements. • Birth parent expenses may include allowable pregnancy-related and living expenses permitted under applicable state laws. These expenses can include medical care, counseling services, housing, utilities, maternity clothing, transportation, groceries, and other approved support
