UNDERSTANDING OF FEES

The above fee schedule represents all the professional fees to be paid to Mi Yungs Prayer (MYP) and estimates of other fees, we/I will face throughout their/my adoptive process. All Third-Party Fees are paid directly to the Service Provider and not MYP. There may be additional miscellaneous costs that include but are not limited to; fees for obtaining birth, marriage, divorce, or other certificates, notarization, authentication and legalization fees, other courier fees, visa and passport fees, court fees in the U.S, child's medical appointments, attorney fees if needed for a validation and other expenses. We/I understand that these other expenses are not the responsibility of MYP under any circumstances. Fees paid to any other sources in the pursuit of adoption will be our/my responsibility even if our/my adoptive placement plans are terminated. We/I understand that MYP will make every effort to help us/me with an adoptive placement if, in MYP's professional opinion, it is in the best interest of a child(ren) to do so. We/I understand that the fees due under this contract are solely to pay for the professional adoption services provided by MYP and cannot be construed as a guarantee of approval for placement or placement of a child or children for the purposes of adoption. We/I understand MYP have/has not accepted any charitable contributions from us/me, six months prior to application to MYP until our/my post adoption has been completed and our/my adoption case is closed with MYP. Donations received from other parties, including grants toward our/my adoption do not influence placement decisions. We/I have been advised that, as adoption

is a legal matter, we/I may wish to obtain an attorney to represent us/myself or to consult with us/myself at any time in the adoption process. We/I understand that MYP is willing to coordinate services with our/my attorney should we/I retain one. We/I understand that retaining an attorney will be at our/my expense. If we/I choose not to obtain the services of an attorney, we/I agree that we/I have been given ample opportunity to do so and have carefully considered that decision and have voluntarily decided not to do so. We/I understand that we/I can terminate our adoption process with MYP at any time before the placement of a child by submitting a written statement to that effect. If any refunds are due, see **MYP Refund Policy**

Fees are to be paid directly to MYP. MYP accepts checks and major credit cards. **Credit card payments are subject to a 3% transaction fee. ACH payments are subject to a 1% transaction fee. If you wish to mail a check, please make the check payable to "Mi Yungs Prayer" and mail to 1272 Gaylord Street, Denver, Colorado 80206. All invoices are due upon receipt.** Any account that is not paid within 60 days after the date of the invoice is considered delinquent. Any unpaid balance for the past 90 days will accrue interest at the rate of 1% per month. We/I understand delaying payment can interrupt the processing of your adoption case. MYP does not take any action to discourage making a complaint or expressing grievance. Please see **MYP Complaint Policy and Procedures**.
